

2019 SUPREME COURT OF THE UNITED STATES ADMISSIONS CEREMONY TRIP SCWLA EVENT APPLICATION

The 2019 group admissions ceremony for the South Carolina Women Lawyers' Association is scheduled for Monday, December 16, 2019. A member of South Carolina's judiciary will move for the admittance of our group to the United States Supreme Court Bar.

LODGING:

SCWLA has arranged a hotel block at the Hyatt Regency Washington on Capitol Hill (400 New Jersey Avenue NW) located conveniently to the Court, as well as the Capitol Hill area of Washington, D.C. * EVENT APPLICATION DEADLINE AND ADDITIONAL INFORMATION:

Please note that, depending upon security requirements of the various buildings/institutions for which we will try to arrange group tours (such as the White House), additional information may be needed (social security numbers, birth dates, etc.). **Because of advance notice for submitting such information, SCWLA members who submit their event applications received after May 15 may not be able to participate in those tours.**

GUESTS:

Admissions Ceremony Guests Information: The seating capacity of the courtroom is limited. Children under six may not be admitted to the Courtroom. The Court limits the number of applicants' guests guaranteed to have a seat to **one per applicant**. It may be that another SCWLA participant may not have a guest so that you may bring two, but you should not make your plans relying upon this possibility. (There is also public seating, but additional guests will have to wait in line with the public for those seats.)

Please note that the SCWLA \$100 administrative fee must be paid by all applicants and for guests to be included in events organized by SCWLA (including Sunday reception and Monday breakfast at the Court).

The deadline for SCWLA's receipt of the Court Application is October 1, 2019 (to ensure the most current application is used and the current fees are paid, please do not submit the Application for Admission to Practice and admissions fee earlier than August 1, 2019).**
